**Subject:** Admission Notification to Left over Seats in various Government / Private Paramedical (B-Pharmacy / D-Pharmacy) Institutions of U.T of Jammu and Kashmir.

Pursuant to S.O 333 , Dated :- 13<sup>th</sup> of June followed by SOP's issued by Administrative Department of Health and Medical Education Vide No:- 378 – JK(HME) of 2024, Dated :- 13.06.2024, It is impressed upon all Government / Private Paramedical (**B-Pharmacy / D-Pharmacy**) Institutions of U.T of J&K duly recognized and affiliated with Pharmacy Council of India Concerned Universities, to invite applications from desirous candidates for admission in the following Courses for the left over seats only for the session 2025-26.

2.	D-Pharmacy

The following terms and conditions shall be followed during the admission process:-

### TERMS AND CONDITIONS

1. The institutions shall follow the eligibility criteria for admission to above mentioned courses strictly as per the eligibility criteria laid down by J&K Government Health and Medical Education Department and as notified by J&K Board of Professional Entrance Examination (JKBOPEE) on its website for session 2025-26 through various notifications for admission to the aforementioned courses.
2. After inviting the applications, the institutions shall draw a merit list on the basis of marks obtained in 10+2 and admit the candidates strictly as per the merit.

3. The last date of admission is **15<sup>th</sup> December 2025** and all the Institution(s) shall finalize / conclude the admission process well by of before the cut-off date.
4. Government and Private Paramedical & Nursing Institutions after completing the admission process shall submit the short-listed admitted candidates against the left-over seats to Jammu & Kashmir Nursing Council for verification of eligibility of the candidates. If upon verification, any candidate, is found ineligible, his / her admission shall be cancelled ab-initio.
5. The dates for Registration / verification by J&K Nursing Council shall be notified separately Institution wise.
6. Only domiciles of UT of Jammu and Kashmir be admitted against the left over seats.

### **NOTE**

1. The Institutions shall invite applications for admission to above mentioned courses against left over seats and while doing so due care must be taken to give it wide publicity in print / electronic media and through institutions website.
2. After due advertisement of selection list by the concerned institutions, the candidates provisionally selected shall report for admission to the concerned institutions by or before **15/12/2025 (upto 5 PM)** along with their relevant certificated in original. The concerned heads of the institutes shall complete the admission process after checking the eligibility of candidates and verifying the following documents :-
  - ✓ Domicile Certificate
  - ✓ 12<sup>th</sup> Marks Card
  - ✓ Valid Category Certificate, If any, in case of Government Institutions
  - ✓ Date of Birth Certificate
  - ✓ Any other certificate required by the college in accordance with the rules
3. Incase Candidates conceal/surpass any information at the time of admission, his/her candidature shall be cancelled abinitio.
4. **The Government Institutions upon finalizing the selection list shall take due care in allocating the reserved category seats as per relevant rules. The seat matrix of Government Institutions is readily available on the website of JK Board of Professional Entrance Examination (JKBOPEE) under head " NOTICES "**



5. The Institutions shall submit the selection list in the Office of J&K Nursing Council by or before 17/12/2025, 5PM on the following e-mail addresses :-
